Subject:- Release of 1st installment of Recurring Central Assistance to the State Government of Chhattisgarh in respect of DIETs, CTEs, IASE, SCERT & MMEs for the year 2017-18 under the Scheme of Teacher Education.

Sir,

I am directed to refer to the minutes of TEAB meeting held on 08.03.2017 for consideration of Annual Work Plan & Budget (AWP&B) of State Government of Chhattisgarh for the year 2017-18 under the Scheme of Teacher Education.

2. The Plan has been appraised for Recurring Central Assistance item-wise and institution wise break-up and estimated by TEAB in respect of DIETs, CTEs, IASE, SCERT & MMEs for the year 2017-18 under the Scheme of Teacher Education to the State Government of Chhattisgarh are as follows:-

3. In pursuance of para 7 of TEAB minutes(2017-18), it is pertinent to State that the Annual Budget provided by Ministry of Finance at Budget Estimate(BE) under the Scheme of Teacher Education is Rs.480.00 Crore. Out of Rs.480.00 Crore, amount allocated to the State Govt. of Chhattisgarh is Rs. 939.04 lakh as Central share only for release in 2017-18. For release of 1st installment (75% of Central share), a sum of Rs. 704.28 lakh has been worked out as per following details:-

- (i) Total allocated amount as Central share (@60%) = Rs.939.04 lakh
- (ii) 1st installment amount being released (75% of Central share) = Rs. 704.28 lakh

5. I am directed to convey the sanction of President of India to the payment of Rs. 98.60 lakhs (Rupees Ninety Eight Lakh and Sixty Thousand only) under **SCSP Head** to the Government of Chhattisgarh as 1st installment of Recurring Central Assistance for 2017-18 to meet the expenditure in respect of DIETs, CTEs, IASEs, SCERT & MMEs under the Scheme of Teacher Education.

6. The amount sanctioned under General & STSP Heads are being issued separately.

7. The above grant of Central assistance shall be subject to the following conditions:-

- (i) Central assistance will be utilized in conformity with the guidelines for the scheme circulated to State Governments vide this Department's D.O. letter No.44-2/2012-EE-9, dated 12.07.2012, and any other guidelines that may be circulated by the Deptt. from time to time.
- (ii) Expenditure on the training programme under other specific schemes (like SSA, EGS/AIE, etc.), shall be met from the funds sanctioned under those schemes and not from the funds sanctioned under Teacher Education Scheme.
- (iii) A copy of every order of State Government according administrative approval or financial sanction for any item of recurring expenditure (including orders concerning posts) in connection with the above institutions will be endorsed to this Department.
- (iv) State Government shall abide by the terms & conditions of the MOU executed by the Ministry and the State Government, and any further guidelines which may be issued by the Ministry from time to time.
- (v) The amount of grant shall be utilized only for the purpose for which it is sanctioned and unspent balance out of the grant, if any, at the end of 2017-18, shall be refunded by the State Government after the close of the financial year unless permission is granted for its being carried forward for utilization for the same purpose during the following financial year.
- (vi) State Govt. shall regularly submit half-yearly progress cum utilization report under the Teacher Education Scheme. Utilization report of amount being released by this sanction letter shall be forwarded by the State Govt. at the earliest and in any case within three months from close of the financial year.
- (vii) Accounts of all grantee institutions shall be made available for inspection by the sanctioning authority for audit whenever asked to do so.

(viii) The accounts of all grantee Institutions or Organizations shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG (DPC) Act 1971 and internal audit by the Principal Accounts Office of the Ministry or Department, whenever the Institution or Organization is called upon to do so and a provision to this effect should invariably be incorporated in all orders sanctioning grants-in-aid.

The Principal Accounts Officer may forward a copy of the advice to the Accountant General and Finance Department of the Government of Chhattisgarh along with a copy to the undersigned.

11. The grantee is located in Chhattisgarh Circle of Accounts.
